TREE REMOVAL POLICY

Policy 13.00

Passed: September 13, 2011

Updated: November 21, 2014

PURPOSE:

The Summer Village of Gull Lake (SVGL) wishes to establish a tree removal policy within a residents operating footprint for fire and safety protection

POLICY STATEMENT AND GUIDELINES:

To establish planning and decision making regarding private lot tree removal taking into account best practices from environmental specialist, reducing wildfire risk and the needs of the SVGL residents to have control over the landscaping of their private lot, taking into account the unique qualities of owning property near the Gull Lake shoreline.

If the intended Development is to remove vegetation to reduce vulnerability to wildfire, the application shall include:

- (i) a plan showing the existing trees, shrubs, and/or natural vegetation, identify the trees, shrubs, and/or natural vegetation to be removed;
- (ii) a statement as to why the trees, shrubs, and/or natural vegetation are proposed to be removed and the space required;
- (iii) details outlining the measures that will be taken to ensure the integrity of trees, shrubs, and/or natural vegetation adjacent to those proposed to be removed is not compromised.

Clear cutting of the parcel is prohibited. Trees, shrubs and natural vegetation is valuable. They reduce soil erosion and therefore protect the Gull lake waters and property value.
